# A LETTER FROM THE DIRECTOR

Dear Friend,

As we embark on The Cabbage Patch's 110th year of empowering youth and families, I am grateful for your faith. Thank you for your faith in the children of The Patch, who inspire us with their stories of perseverance and redemption. Thank you for your faith in the Board and staff of The Patch, who prove themselves to be good stewards of your generous donations time and time again. Not least of all, I thank you for your faith in me as I learn from The Cabbage Patch's past while leading the organization into the future.

As we sent this Annual Report to print, we were grappling with the implications of COVID-19. **In April 2020 alone, we gave out 5 and a half times more food than we usually do in an average month.** The families we serve have been overwhelmed with job loss and financial burden. The long recovery process has only just started, but still I have faith.

Your support has put The Cabbage Patch in a good position to deal with crisis situations. The Patch was there for people during the 1918 influenza epidemic; the Great Depression; 9/11; the Great Recession ; and we will persevere through the age of COVID-19. **Thank you for providing stability to our families in a time of great uncertainty.**

# MEET COREY!

We are so excited to have our new Executive Director on board! Rev. Dr. Corey Miller comes to The Cabbage Patch from the Boys and Girls Clubs of Kentuckiana, where he served as Vice President of Development and Communications. Before relocating to Louisville from North Carolina, he served as Executive Director of Smart Start and Director of Philanthropy at Crisis Control Ministry before being appointed Executive Director of Development and the Foundation for Forsyth Technical Community College. He holds a bachelor's degree in political science from Sewanee: The University of the South, a master's degree in public administration from the University of Kentucky, a master's degree in divinity from Duke University and a Doctor of Ministry from Drew University.

Corey is an ordained Elder in the United Methodist Church and served for eight years as an Associate Pastor in the Western North Carolina Annual Conference. Currently, he is a member of Christ Church United Methodist here in Louisville. Corey is married to Elizabeth (Beth) Miller, a medical physicist with Norton Cancer Institute, and their son, Caldwell, is a recent graduate of Rhodes College and newly commissioned officer in the U.S. Navy.



## We Asked Corey:

### **If you could pick one person, living or dead, to have a conversation with, who would it be?**

I would be very interested to have a conversation with Dr. Martin Luther King, Jr. He was a talented leader on political, social, and spiritual levels. I would like to get his impression of the current environment and his perspective on what he considers the most important aspects of leadership.

### **What do you see as your greatest professional accomplishment?**

My greatest professional accomplishment occurred when I was at the Foundation of Forsyth Technical Community College in North Carolina. I came into the lead advancement role in a capital campaign at the 60% mark and helped raise the remaining \$8 Million in one year. Our motivation was the impact of the new opportunities for our students.

### **Tell us about a significant role model or mentor in your life.**

A significant role model for me was my grandmother, Louise. Through our interactions, she helped me to gain a larger view of the world. She believed in open and honest conversation and modeled the unconditional love that I strive to give to my family. When I read about Louise Marshall's strong will, it reminds me of her!

### **What is your favorite book you have ever read?**

I am an avid reader, so it is difficult to select one, but it would have to be *What's So Amazing About Grace* by Philip Yancey. Yancey's message is that Christians should be best known to the world by their love of neighbor, and offer grace easily to others. His book is both powerful and prescriptive, and suggests a positive way forward.

## “COLLEGE IS A BETTER CHANCE AT A BETTER LIFE!”

Teen Debate Club is a new initiative in the Educational Opportunities Department that seeks to develop public speaking, reasoning, and argument-building skills in teens. Recently, we took a break from debating current event topics to have a discussion-based session. The teens present were asked to discuss their future plans and to reflect on the personal challenges that might stand in the way of these plans. In attendance were three members who have participated in many college prep programs at The Cabbage Patch.

Laron, Tamon, and Jamiah at first seemed lackadaisical about participating, which threw them in sharp contrast to another young man who was more than willing to express his point of view. When asked to share, Derrick, a 10th grader, readily confessed that he hated school and regularly missed class. He felt that college was unnecessary for him as he knew many people who made money and had not gone to school. Tamon chimed in that college is not a guarantee of success, but that it definitely helps, and Jamiah agreed. “Why set yourself back?” Laron questioned, “College is a better chance at a better life.”

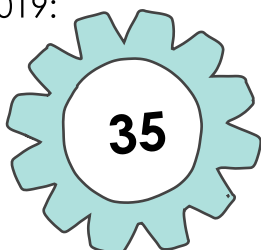
The debate lasted until the end of the hour with Tamon and Laron offering a compelling argument for college. Though Derrick will still need to be fully convinced, the sight of



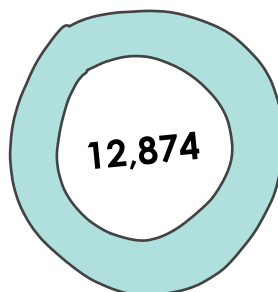
two peers passionately extolling the benefits of college demonstrated the impact our college prep programs have on our youth.

Thank you for helping to create positive peer groups in which young people encourage each other to do their best. With your support, The Patch fosters a sense of community that is centered on education!

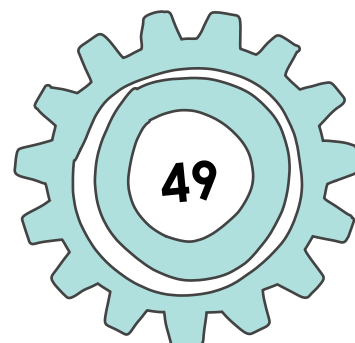
Total College

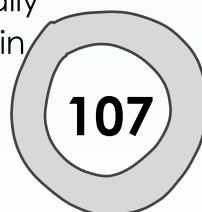

## THE MARVELOUS MEYERS

When a Cabbage Patch supporter considers establishing a named fund, they often think about how they want the endowment to be used. Some are inspired by the life-changing educational opportunities, while others want to ensure the sustainability of youth development activities like arts and athletics. **Former Board President Bill Meyer and his wife Becky had a different perspective.**

"We want to be as flexible as possible as to how our named endowment fund is used," Bill says. "After serving on the Board, I know that there are so many different expenses behind the success of Cabbage Patch programs, and we want Cabbage Patch leaders to have the ability to use their judgement as to how our funds are best used at any given point in time."

Bill has been a part of The Cabbage Patch family for many years, including 6 years serving on the Board of Directors. Becky's uncle, Don Kurfees, was the executor of Cabbage Patch founder Louise Marshall's estate. When Bill's client, former Board President Walt Kunau, recommended him for a Board position, he was already well acquainted with The Patch's success stories and was eager to help change the lives of local youth.

As part of The Cabbage Patch's comprehensive campaign, Bill and Becky made a pledge payable over several years and included part of their estate so that they could maximize their contribution to The Cabbage Patch's endowments.



While there are several worthy youth organizations in Louisville, it was important to Bill and Becky that a portion of their estate go to benefit a Christian organization.

## A SECOND CHANCE CAN CHANGE A LIFE

We received a grant from the Kentucky Social Welfare Foundation that is dedicated to helping with records expungement! We are so thankful for this gift that will fund life-changing work benefiting clients like Samuel.

Samuel and his wife are the parents of three children who are active in Cabbage Patch programs. Samuel's wife has a health problem that results in frequent hospitalizations, and she is not able to work. When Samuel was younger, he made some poor choices that resulted in him being arrested on several occasions and being charged with 13 misdemeanors. Samuel is older now, has changed his life and is trying to get these charges expunged from his record. Eight can be expunged for free, but the total cost to expunge the other five charges will be almost \$550.



Family Development offers camaraderie and assistance so that Patch Parents can maximize their resources.

Samuel has difficulty finding work as it appears that employers decide not to hire him after they see a copy of his criminal background check. Having these charges expunged would make it easier for Samuel to gain a higher paying job and this would allow him to provide for his family. This family lives below the poverty line and is dependent on multiple assistance programs (e.g. SNAP benefits, Low Income Home Energy Assistance Program, financial assistance from local churches, Cabbage Patch food pantry, and Cabbage Patch utility assistance).

## HOLLIE HUSTON

Hollie Huston came to The Patch as a six-year-old in the daycare program. She dared to dream but had no idea just how far her dreams would take her! Hollie grew up with The Patch "legends;" Jacky Shea, Mr. Chin, Mr. Napier, Mr. Dietsch and countless other unforgettable members of The Patch community. It was a family affair for Hollie, as her grandparents were Patch members, and her parents met at The Patch. When Hollie's grandfather passed away, Mr. Chin, Mr. Cooksey and Mr. Dietsch sat with Hollie's family for hours, telling old stories.

Hollie's favorite memories of The Patch come from her experiences in High Adventure Club. "How many people can say they have been on a hundred mile canoe trip?" Hollie says. "We worked to earn our places on that trip, and we knew that it made each of us something special!"

Hollie showed incredible patience and commitment as she pursued her college degree while raising two children. After graduating high school in 1997, she worked for a summer at The Cabbage Patch and later found a great job at Jefferson Community and Technical College, making her eligible for tuition assistance with the University of Louisville.

When she was granted custody of a family member's children, Family Development helped her navigate the family court system while Educational Opportunities supported her academic pursuits. Everyone knew she was in for

a marathon, not a sprint. Hollie completed one class at a time at a pace that would allow her to be successful as both a student and a parent. In December of 2018, she earned her degree in sociology, making her eligible for a promotion in her career at JCTC.

## PICKLEBALL

**What is pickleball? It's something like a combination of badminton, ping pong and tennis. The combination of fun, fitness and community make pickleball one of the country's fastest growing sports, but what does it have to do with pickles?**

"Pickleball was invented in 1965 near Seattle," explains Cabbage Patch alumna and volunteer Cheryl Rothgerber. "It is rumored to be named after the family dog, Pickles, who loved to chase the ball and run off with it!"

Cheryl and her husband Art had the idea to volunteer their time teaching and coaching pickleball after touring The Patch with former Board member Pat Hayden. Cheryl has fond memories of playing basketball, softball and volleyball at The Patch as a teenager, and Art likes to tell people about how he would come watch her games when he was courting her. When Art and Cheryl met Pat while playing pickleball at the Jewish Community Center, they were excited to revisit the place where they had so many happy times during their youth.

"Pickleball requires discipline, teamwork and self-control... the game is played between the lines," says Art. "You can't just hit the ball as hard as you can. The kids really become mindful of boundaries and developing the skill to stay in bounds."
